

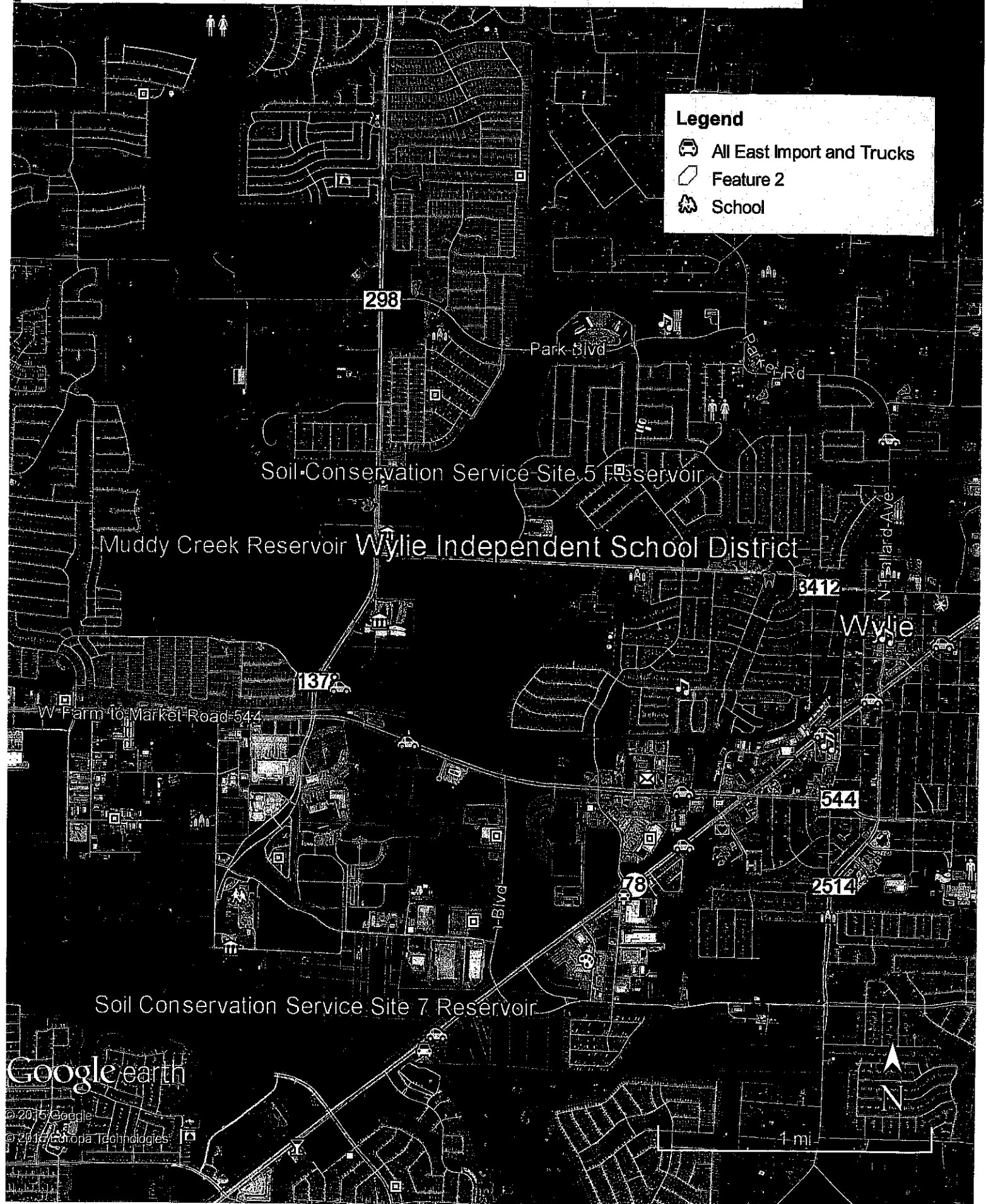

ASSOCIATION'S BOUNDARY DESCRIPTION

Then turn right off of N. Country Club Road onto W. Anchor Dr. and going East until the end of W. Anchor Dr. cul-de-sac and just beyond to the property line and current City limit of Wylie, also being at a drainage ditch;

Then going South following the drainage ditch and being behind the back property line of the lots facing Spinnaker Way and further along South with the property line until Park Blvd.:

Then still going South crossing Park Blvd. and following the center line of what is now a creek which drains into Soil Conservation Service Site No. 5 Reservoir, and still going further South past the Reservoir No. 5 down the center of the creek crossing W. Brown and following the creek South until W. FM 544;

Then East along W. FM 544 until Westgate Way;

Then South along Westgate Way to Highway 78;

Then South jog short distance on Highway 78 onto Martinez Lane, proceeding South on Martinez Lane to Alanis Drive;

Then West on Alanis Drive to the West line of the Glen Knoll Mobile Home Park;

Then South along the West property line of the Glen Knoll Mobile Home Park until the North property line of the Woodbridge Golf Club;

Then going West along the North line of the Woodbridge Golf Club to the East corner of Lot 1, Woodbridge Villas property, and further West following the Northeast lien of the Lot 1, Woodbridge Villas property until State Highway 78;

Then Northwest crossing State Highway 78 to the west side of the Soil Conservation Service Site No. 7 Reservoir;

Then Northwest past Reservoir Site No. 7 and following the Creek to Hensley Lane;

Then West along Hensley Lane to Hooper Road, thereafter North along Hooper Road to W. FM 544;

Then West along W. FM 544 until Springwell Parkway, thereafter North along Springwell Parkway until Marshall Lane;

Then North and East along Marshall Lane until N. Country Club Road;

Then North along N. Country Club Road to the Place of Beginning.

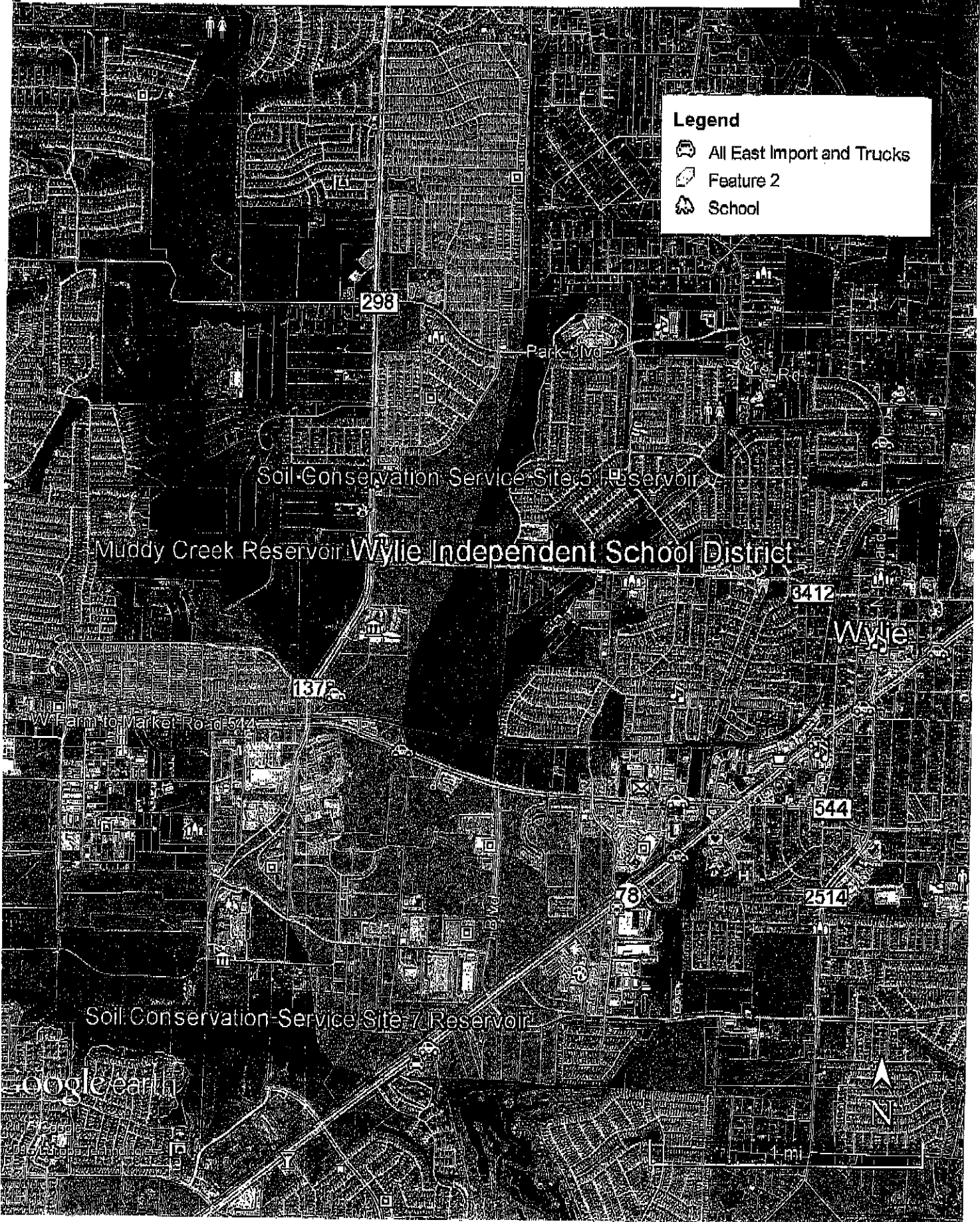
