Our allocation this year is 9,808,885, just slightly lower than our 22 allocation. The table one in your handout shows the amount that is actually going to be out for competition, and that is a total of 9,000,367 485,000. And it shows how the breakdown of each COC is going to be. Now that amount is going to be for both the continuing awards and the competition. So we are working currently on finalizing who is eligible for a continuing award. We do have right now preliminarily 29 entities that are eligible and everybody that has had an allocation, three out of the last four regular allocations was reviewed for eligibility and out of those we had about 70. 29 are showing to be potentially eligible and we'll finalize that this week. We're going to be reaching out to those recipients by the end of the week and then midweek next week, those eligible will receive their application. All of the COC's except for 604, 611, 624 and 701 had at least one eligible will continue an award within them. So we are going to share those budgets with you all As soon as we have reached out to those eligible, there will still be amounts within those regions for the continuing awards, but it will be a slighter less percentage than we did last year because we have more people eligible this year. So before I move on to CARES there, are there any questions on that I know was a lot of information.

So our SUP recipients have expended just a little over 92 million as of their March report. So we do think we are in line to be able to fully expend those funds by September 30th. Our third allocation that we are in the finalizing process and the contracting, all the contracts have been sent out. They are signed. We are reaching out to people within

But given the short amount of time that we have to expand the 5.5 million, the best course of action was to give it to existing programs that could handle that amount of money in the short amount of time. Okay. So the last two pages of the handout show some of the performance that our sub recipients have done, some of the services they've provided with the 92 million that has been expended so far, I would like to highlight a couple of things overall, as of April, our subs have served over 65,000 households. That's 92,812 persons with either street outreach, emergency shelter, rapid rehousing and or homeless prevention services. Overall, our ESG cares funds have been used to help over 1.7 million.... 1.7 billion... million bed nights at an emergency shelter. More than 14,000 of those persons served were victims of victims of or fleeing domestic violence. Of the 8231 households served with rapid rehousing, more than 50% were placed in permanent housing within 60 days, and more than 13,000 households received rental assistance through either rapid rehousing or homeless prevention. I know we talk a lot about expenditures and money spend, and so we thought we'd highlight some of that, what that actually means for the people that are serving. That's all I had

We have an allocated spend submitted to HUD program funds into rental non profit capacity building, operating costs and not hard to get shelter. The rental is underway. So it is we released an offer in December and we are hoping to award between May and July. So I have several, hopefully several awards going to may and then each one possibly about 10 to 12 total. In that month, we did have half we had about 3.2 million in non profit capacity building operating costs for rental, which we ended up rolling into development because there was such demand for funding there. And we were oversubscribed over 2 to 1. For the (indistinguishable) shelter. We have the we still have non profit capacity building operating cost assistance to support an organization to fight for government. And we do have a plan amendment first amendment out for public comment right now that focuses the funds on areas

that may have high needs for a larger shelter and some criteria for that profit to meet in order to be awarded. And then if they're awarded that non public capacity funding in order to streamline the application process, they would research funds for the nonprofit shelter working to get the funding moving that way.

All of that activity so far has come from the Texas homeless network. So we have a great partnership establish our proof of concept is beyond proven and we're just, you know, making steady incremental progress to get us from 195 house currently up to the 380, which is our goal. We're on pace to hit that within our time frame. So everything with (indistinguishable) is going great. We've also

onboarded two other COC or Continuum of Care Partners, and that's Tarrant County Homeless Coalition and the Heart of Texas Homeless Coalition that serves the Waco area. We've been meeting weekly with both of those partners. We don't have any housed folks yet, but we do have 34 referrals from Tarrant. County. And those initial those initial 34 are people who are in some kind of temporary. Assistance program. And they need to move on. So we're going to deploy the Section eight vouchers to those critical folks that are at risk of losing temporary subsidy. And then we'll move on to other eligible populations. And with Tarrant County, our goal is for 368 households. And then lastly, we have part of Texas that's a 50 voucher allocation. Right now we have a contract signed with them. They have the ability to draw down funds from our housing contract system, but we're still in the early stages or doing things like process mapping, you know, writing joint inter organizational facilities and all that kind of program development stuff. So that's where we are right now.

So you have all of the Section eight housing choice voucher requirements, the income requirements, the cred..., the criminal screening criteria, things like that. And then with these particular

Section eight vouchers, you have to have a referral process set up with the COC or other eligible referral entity. And then there are specific target populations which have, you know, lengthy definitions. But basically they are people experiencing homelessness, people exiting from homelessness, people who are survivors of domestic violence or, you know, fleeing. You know, there's a long definition for what we think of as the by law population. And so so I think that so so that's basically anti homelessness program using the Section eight housing choice vouchers. And then one of the cool things about EHV there's \$35,000 per voucher that is used for housing search assistance, landlord incentives and things like that.

So this would be a text related program that collects funds for local homelessness programs, you know, similar to the ending homelessness fund. But rather than giving money, when you go to register your car, you can, you know, like a Red Cross, you can text, provide funds.

So it requires a TICH to sell you the housing needs of youth transitioning from foster care and of the juvenile justice justice system to independent living. And that one has also been reported favorably. And then on the Senate side of things, there are a couple of bills. SB 1803 by Senator Springer relate to the effectiveness, effectiveness of state funded homelessness programs at helping beneficiaries advance toward self-sufficiency. This is one that we require SAO to audit state agencies use of funds to assist homeless individuals. There's a list of agencies including TDHCA, HHFC, TBC, TWC, TEA, TDCJ, DFPS, and how those funds are utilized and the efficiency of those funds in assisting homeless individuals. Then finally got SB 2018 by Senator Flores, which relates to prohibitions on camping in public places. It's somewhat of an amendment to the bill was passed last session about camping in public spaces. Adds some new pieces to that and provides some enforcement authority to the AG's office and others if certain complaint requirements aren't met by local municipalities.
